Withdrawal of Nominations	10.12.2024 (Between 10.00 am and 5.00 pm)
Publishing of Final List of Candidates	10.12.2024 at 6.00 p.m.
Date of Election	15.12.2024 (Between 10.00 am and 5.00 pm)
Counting of Votes	15.12.2024 6.00 pm

3. Only the primary members of the Chennai Press Club alone will be eligible to contest the Election.

4. The list of eligible voters is published along with this Notification and the same will be affixed on the Club's Notice Board and also uploaded in the website **[www.chennaipressclub.com](http://www.chennaipressclub.com)**.

5. The Model Code of Conduct (MCC) is published along with this Notification, and shall be in force from today till the declaration of results.



6. The nomination form shall be filed in the prescribed format, with the signatures of the candidate, the proposer and the seconder, who are primary members of the Chennai Press Club, and submitted to the Assistant Election Officers appointed by the Election Officer, at the office premises of the Chennai Press Club, as per the Election Schedule. Nomination forms are available with the Assistant Election Officers.
7. The nomination forms shall be filed by the contesting candidates in person.
8. A copy of <sup>✓ Regent</sup> valid Chennai Press Club ID card of the candidate, proposer and seconder shall be <sup>✓</sup> attached with the nomination form.
9. As per the By-Laws, members who are in arrears of subscription or who have not paid their dues to the Club cannot contest elections or act as proposer or seconder.
10. Note to Voters :
  - All members whose names are found in the Voter List published along with this Notification are eligible to vote in the elections ;
  - Voters shall bring their <sup>Regent</sup> Chennai Press Club Membership Card as proof of membership and identity on the day of election to cast their votes. It is made clear that those without Chennai Press Club ID cards will not be allowed to vote.
11.
